

MINUTES OF THE MEETING OF THE GENERAL BODY OF THE DHALAI DISTRICT
e-GOVERNANCE SOCIETY.

The D.M & Collector, Dhalai welcomed the Hon'ble Sabhadhipati, Dhalai Zilla Parishad, and other participants. He initiated the discussions and explained the purpose of the meeting. He requested the State Manager, CSC to explain the functions of CSC 2.0 scheme.

The State Manager, CSC explained about the CSC 2.0 scheme through video clip which displayed the experience of Village Level Entrepreneur (VLE) and common people about CSC. It was explained how a VLE and citizen are getting benefits through CSC. The roles of CSC 2.0 scheme in rural areas of GP/VCs were also explained.

The District Manager, CSC, Dhalai District presented the present status of CSC in the District. It was mentioned that out of 151 GP/VCs of Dhalai District, CSC are functioning in only 24 GP/VCs. Hence, the target is to cover the rest GP/VCs with CSC.

A few participants expressed their concern about poor availability of internet services in the District. It was decided that at initial stage, CSCs may start functioning near the Block Headquarters on pilot basis.

The Project Engineer and Consultant, Railtel (NOFN) appraised the current status of National Optical Fiber Network (NOFN) connectivity in Dhalai District. They have set up Optic Fiber Cable (OFC) in 105 GP/VCs out of the targeted 127 GP/VCs. He informed that due to non-receipt of equipments from Bharat Broadband Network Ltd. (BBNL), they are not in a position to provide internet connectivity to the 105 GP/VCs.

It was decided that Block Level Awareness meeting would be conducted as follows. The concerned BDO's will arrange the meeting with all the Chairpersons/Pradhans and Panchayet secretary of GP/VCs and also local un-employed youths of the Block area.
