

-:TERMS & CONDITIONS:-

1. The entire articles will be sold as single wise, lot wise or separate items-wise. The articles will be sold on the assumption that the tenderer has to be inspected the articles at store of this office and it is fully aware of the condition of the articles he/she is interested in buying.
2. The articles may be inspected up to 28th May, 2017 between 10:30 AM to 4:00 PM in front of the Nazarat Section, Office of the DM & Collector, Dhalai District.
3. Rates should be quoted either items -wise as per financial bid, rate should be quoted both in figure and in words.
4. The bidders should submit INR 7,000/- as security deposit by draft /D-Call drawn in any nationalized bank along with the tender.
5. Each tenderer must ensure before sending their tender forms that their particulars are properly furnished in the tender documents. Tenderer may be selected based on overall rates offered for all items or may be of individual items.
6. The bidder shall be required to place the earnest money and the bidding sheet in separate sealed envelope which should be super scribed "Tender document for purchase of un-unserviceable articles" offer without earnest money will be treated as invalid.
7. The scaled tender should be addressed to the Office of the DM & Collector, Dhalai District and reach by hand and also post (up to 5:00 PM of 29th May, 2017) for any postal or courier delay the office will not be responsible.
8. The successful tenderer(s) have to pay the full amount in cheque only on in any nationalized bank in favour of the DM & Collector, Dhalai and arrange for removal of the articles within 48 Hours of the deposit of the amount with receipt.
9. If the tenderer(s) once accepted, fails to deposit the full amount mentioned in tender within the stipulated time the EMD will be forfeited to the govt. and the articles will be sold to next higher bidder or otherwise as per the decision of the competent authority.
10. This office will not be responsible for any loss or damage to the articles, if the tenderer(s) fails to take delivery of the articles within the prescribed time limit in case of default in payment of the sale proceeds and or in taking delivery of the articles within the prescribed time limit, this office will have full right to dispose of the articles in any other manner deemed fit after forfeiting all payment made by the tenderer(s) including EMD and the said tenderer(s) will have no right to claim the said articles.
11. No extension of time limit will be granted for payment of the full amount of the tender and /or removal of articles from the office premises.
12. This office has the right to reject any or all tenders without assigning any reason whatsoever or to split up the entries lot of the articles to more than one bidder.
13. In the event of any dispute, the decision of Authority is final and bidding upon all.
